## PURSUANT TO CONN. GEN. STAT. § 30-43 AS AMENDED:

Pursuant to Chapter 545 generally and specifically Section 30-55 of the Connecticut General Statutes as amended, you and a member of the backer limited liability company are hereby summoned to appear before the Department of Consumer Protection of the State of Connecticut, on the 6<sup>th</sup> day of April 2023 at 3:00 p.m., remotely through Microsoft Teams, then and there to answer to the complaint and charges of said Division, the particulars of which are as follows:

### **Incident 1. March 17, 2023**

**Charge 1.** New applications. On or about March 17, 2023, you violated Sec. 30-6-A1 of the Regulations of Connecticut State Agencies which provides, in relevant part, that when a new application is received at the department, no permit shall be issued until the applicant complies with all statutes, regulations, policies and stipulations of the department.

## As more particularly set forth:

On February 22, 2023, the Department required the applicant, whose premise was under construction and who had stipulated that he would open his premises by April 1, 2023, to have his premises ready to open by April 1, 2023, or his application for a liquor permit would be returned, as the permit, if granted, would be the last package store permit allowed in Lebanon. On March 17, 2023, the applicant advised the Department that his premise would not be ready to open by April 1, 2023, and requested an extension until August 1, 2023 to open his premises.

PLEASE BE ADVISED THAT YOU WILL BE EXPECTED TO APPEAR WHEN YOUR HEARING IS CALLED BY THE COMMISSION. FAILURE TO APPEAR AT THE DESIGNATED TIME MAY RESULT IN A DEFAULT. YOU WILL BE REQUIRED TO SHOW CAUSE, IF THERE BE ANY, WHY YOUR LIQUOR PERMIT SHOULD NOT BE REVOKED OR SUSPENDED OR ANY OTHER AUTHORIZED PENALTY IMPOSED ON YOU.
