On April 24, 2019, Governor Ned Lamont issued Executive Order No. 1¹ which directed Connecticut's state agencies to reduce greenhouse gas emissions, curb wasteful water use, and reduce the amount of waste disposed at state facilities. Over the past decade, state agencies have participated in [Lead By Example](#) Initiatives to achieve cost savings through energy conservation. To continue Connecticut's sustainability success the GreenerGov Steering Committee was established as part of Executive Order 1.
