





## **Traffic Signal Interconnect**

- Existing: Traffic Signals Utilize Combination of:
  - Copper Wire Communications System Aerial & Underground
  - Existing System Has Experienced Operational and Maintenance Issues
- Proposed: 48-Strand Fiber Optic Cable (FOC) Aerial Interconnect Along Length of Corridor
- Connectivity to CTDOT Highway Operations Center (HOC) via Wireless Cellular Communications
- Maintain Existing Communications System and Connectivity until New FOC is Operational




Typical Aerial Cable Installation and Splice Enclosure




