



### **Purpose and Need**




- Support transition to a sustainable, efficient and accessible transit system with all-electric fleet


## **Project Overview & Highlights**

  - Bus and van interior parking, storage & charging (46 spaces)
  - Admin/office spaces
- Solar-ready rooftop design
- Onsite solar farm to provide power to the facility
- Existing building to be renovated under separate project






## **Proposed Site Layout**
