The purpose of these projects is to provide new structures that will address the deficiencies of the existing ones while allowing the original superstructure and culvert to remain in place, extending the service life of crossing Park Road and Cooktown Road.

Right-of-way impacts consist of permanent slope easements and a right-to-grade driveways to accommodate the raise in the roadway profile as well as temporary construction easements for the contractor to complete the work.

Construction is anticipated to begin in spring 2027 based on the availability of funding, acquisition of rights of way, and approval of permit(s).

The estimated construction cost for the replacement of Bridge No. 05520 is approximately \$2.8 million. The estimated construction cost for the replacement of Bridge No. 06085 is approximately \$2.6 million. These projects are anticipated to be undertaken with 80% federal funds and 20% state funds.
