

**Water Planning Council Advisory Group (WPCAG)
Proposed 2021 Membership Slate
Approved by Water Planning Council (WPC) XXX, 2020**

WPCAG members serve four-year terms, which are staggered so that the terms of 5 of the 20 member's terms are renewed each year. On September 15, 2020, the WPCAG voted to forward this proposed slate of members to the WPC for approval.

Group 1 members began their 4-year terms starting January 1, 2019. The WPC will need to appoint/reappoint members of Group 3 for 4-year terms beginning January 1, 2021. The remaining WPCAG members will serve out the remainder of their appointments until their group is slated for reappointment. There are no term limits. The upcoming terms for each Group are:

Group 1: Jan 1, 2019 thru Dec 31, 2022 Group 3: Jan 1, 2021 thru Dec 31, 2024

Group 2: Jan 1, 2020 thru Dec 31, 2023 Group 4: Jan 1, 2022 thru Dec 31, 2025

Group 3 will begin their four-year term on January 1, 2021; upon approval of this membership slate.
