

PUBLIC MEETING NOTICE

The Department of Transportation (Department) will conduct a Virtual Public Information Meeting concerning the proposed Rehabilitation of Four Railroad Bridges on the Pan America (Pan Am) Railways Line located in Waterbury on Thursday, June 24 at 6:00 p.m. The meeting will be live streamed via Microsoft Teams Live Event and YouTube Live. A Question and Answer session will immediately follow the presentation. The presentation will be recorded. The live stream of the formal presentation will begin 6:00 p.m.

The project is identified as State Project No. 0170-3320.

The purpose of the project is to rehabilitate four railroad bridges on Pan Am Railways Line in Waterbury, CT.

Project Description:

The rehabilitation of Pan Am railroad bridges was initiated to address deteriorating conditions of the bridges. The project includes superstructures replacement and rehabilitation, culvert re-lining, substructures retrofit and retaining wall rehabilitation. The project construction is anticipated to begin in March of 2022 and end in March of 2023.

There are right-of-way impacts associated with the proposed project.

Temporary construction easement is being acquired from the owner of an adjacent parking lot to facilitate access for the retaining wall repair.

Construction is anticipated to begin in Winter of 2022 based on the availability of funding, acquisition of rights of way and approval of permit(s). This project is anticipated to be undertaken with 100 percent State funds.

The public informational meeting is being held to provide the public and local community the opportunity to offer comments or ask questions regarding the proposed project.
