The review will be conducted in accordance with Chapter 54 of the Connecticut General Statutes.

At the meeting you will be given the opportunity to show that you have met the qualifications necessary to obtain a P-1 license, as defined in the Regulations of Connecticut State Agencies, Section 20-332-4(a). Any evidence you would like considered by the board must be received by the Board Administrator one week prior to the meeting date. Please send evidence to the attention of Jennifer Rector, Board Administrator, Jennifer.Rector@ct.gov.

The Board Administrator will provide you with a link to attend the Zoom Video Conference, please confirm upon receipt of this notification that the Board Administrator has your correct email address. To attend the meeting via Zoom you will need a computer with an enabled camera and a microphone, or a smartphone or tablet with audio and video capability. If you are unable to use the Zoom video option, you must notify the Board Administrator within one week of receipt of this notice. Fifteen (15) minutes prior to the start of the meeting, click on the link provided and you will be taken to the Zoom meeting page.

On the day of the meeting choose a quiet place with no distractions. You cannot participate in the meeting while driving. Have any paperwork you need to consult on hand. If you are having trouble connecting to the meeting by Zoom, call DCP IT support at 860-840-2075 or email DCP.HelpDesk@ct.gov. When you connect to the meeting, the Board Administrator may ask you some questions to verify your identity. These may include your date of birth, address, and last four digits of your social security number. When participating please keep
