REQUEST FOR EMERGENCY HEARING
RE: Notice of Termination

Dear Commissioners:

Deane & Hoyle Brands, Inc. (LSW.1716), hereby requested an emergency hearing on the termination of Murphy Beverage Company, Inc. under Connecticut General Statutes § 30-17. The ground for this request is an emergency exists, caused by the wholesaler, which threatens our products and business. Specifically, Murphy Beverage Company, Inc. has not paid for any inventory purchased from us (and sold by it) since July of 2023 and currently owes our company in excess of \$175,000.00. Our projections show that unless we advance additional goods or that Murphy agrees to pay on a COD basis it will run out of inventory either later this week or early next week.
