A Regular Meeting of the Public Utilities Regulatory Authority was convened on Wednesday, April 13, 2022 at 10:00 a.m., concerning the following:

A. Consideration of the following proposed Final Interim Decisions (**REGULAR CALENDAR**):

1. Docket No. 22-01-03 – PURA Annual Review of the Rate Adjustment Mechanisms of The Connecticut Light and Power Company (GBC/mlh)

Chairman Gillett opened the meeting, announced that Docket No. 22-01-03 was incorrectly noted on the agenda as “21-01-03”, and asked PURA Director Joshua Ryor to summarize the proposed Final Interim Decision. Vice Chairman Betkoski moved for approval, Commissioner Caron seconded. The vote in favor was unanimous.

2. Docket No. 22-01-04 – PURA Annual Review of the Rate Adjustment Mechanisms of The United Illuminating Company (GBC/sab)

Chairman asked PURA Staff Sulaiman Bakare to summarize the proposed Final Interim Decision. Vice Chairman Betkoski moved for approval, Commissioner Caron seconded. The vote in favor was unanimous.
