- WHEREAS, Connecticut State Colleges and Universities President Mark E. Ojakian, after due deliberation, has presented a recommendation on such appointment for the Board's consideration; now, therefore, be it
- **RESOLVED,** that, consistent with the recommendation made by President Ojakian, the Board of Regents for Higher Education hereby appoints Susan E. Pease as Interim President of Central Connecticut State University effective from September 20, 2016, to December 31, 2016, or until such time as a President is appointed by the Board, whichever occurs first; and be it further
- **RESOLVED,** that, with gratitude, the Board hereby accepts Dr. Pease's offer to perform the duties of Interim President of Central Connecticut State University for no additional compensation, and be it further
- **RESOLVED,** that, for the duration of her appointment as Interim President of Central Connecticut State University, Dr. Pease will continue to perform the duties of her position as Dean of the Carol A. Ammon College of Liberal Arts and Social Sciences, and be it further
- **RESOLVED,** that Dr. Pease will return to her position as Dean at Central Connecticut State University upon the conclusion of her interim appointment.
