1. Call to Order

Co-chair Alicea Charamut called the meeting to order without a quorum present and everyone introduced themselves.

2. Approval of draft 8/15/2023 and 9/19/2023 Minutes

A quorum was not present at first and returned to this item later and a motion was made and seconded to approve the draft $\frac{8/15/2023}{2023}$ and $\frac{9/19/2023}{2023}$ minutes. The motion was approved unanimously.

3. Upcoming Webinar

Alicea Charamut described the upcoming webinar and there was a discussion of an error on the webinar's flyer.

4. Discussion: Future of WPCAG & IWG

• Recap of WPC and IWG meetings and further discussion & recommendations

There was a discussion of options for the IWG and WPCAG and Jack Betkoski said WPC members favor combining the groups, but with each WPC agency assigning a liaison to the group rather than being represented by a voting member as they are on the IWG. There was a discussion of various aspects of WPCAG membership, including the staggering of members' 4-yr terms, some members' attendance issues, and the WPCAG's statutory framework and the possibility of changing that.

There also was a discussion of the assignment and oversight of subgroups currently divided between the IWG and WPCAG and whether consolidation would increase the burden on administration of the WPCAG. It was also suggested that there be greater business & industry involvement in the WPCAG, beyond the water industry and intensive water use sectors already represented, and an associated discussion of the division of WPCAG membership and leadership between in-stream, out-of-stream, and neutral interests.

Virginia de Lima recommended a work group develop plan implementation metrics, both quantitative and qualitative, and Jack Betkoski said such metrics would help in obtaining funding. Virginia also suggested that a group consider what an updated plan should look like. Alicea Charamut recommended it be a small group focusing on desired changes to the plan and she asked Jack Betkoski if the recommendation can be included on the next WPC agenda.

Iris Kaminski asked if a WPCAG position can be created for a representative of the public. Jack Betkoski said the Office of Consumer Counsel fills that role and Alicea Charamut added that public participation increases when a controversial issue is being considered. She also suggested that a group work on operational procedures.

5. Updates

a. Other Water Planning Council Updates

Alicea Charamut reported that Martin Heft had said there is a possibility that a staff member budgeted to be hired at OPM in FY 2024-25 might be able to assist the WPC. Jack Betkoski said the WPC might be supported by half of a person's time and added that some funding might be available for the water plan.

Ali Hibbard mentioned a recent presentation to the group by DPH's Eric Lindquist regarding flash drought.

Ali Hibbard said the work group's draft report is being revised.

• WPC Annual Report

Virginia de Lima suggested the WPC consider having the group prepare two annual reports: a concise report to the legislature and a more detailed report to the WPC that compiles the information produced by the subgroups. Jack Betkoski agreed with that approach.

6. WPCAG Work Group Updates

a. Watershed Lands Work Group

Margaret Miner said Rich Hanratty is the new co-chair and that there are a couple policy issues to consider. Rich recommended looking at the relationship between the Aquifer Protection Area <u>statutes</u> & <u>regulations</u> and suggested reaching out to representative municipalities regarding how the regulations work for them.

b. Source Water Protection Work Group: <u>Source Water Protection Outline</u>

Alicea Charamut said the group continues to look at the white paper.

c. Solar Siting Work Group: Draft Solar Siting Recommendations & Work Plan

There was no update.

d. Conservation Pricing and Rate Recovery Analysis Work Group

Alicea said the group is developing a survey to send water utilities and explained the intent of the survey.

7. Old Business

a. <u>Water Utility Coordinating Committee</u> (WUCC) update

There was no update.

b. Interagency Drought Work Group update

Becca Dahl said the group did not meet this month and plans to meet in November and has submitted the <u>2022 drought after action report</u>. Virginia de Lima said the group's current approach of having monthly standing meetings that can be canceled if unnecessary is better than the alternative.

c. Nominating Committee

Carol Haskins provided an overview of current vacancies and identified candidates for the recreation and business & industry association positions. The consumer representative position must be refilled and she mentioned that Kathy Czepiel is expected to fill the vacancy left by Karen Burnaska's retirement. There was a motion to approve the presented slate of members for 2024 and the motion was seconded and approved unanimously. Jack Betkoski thanked Carol Haskins for her work on that and Carol Haskins asked members to confirm their alternates.

d. Hydrilla update

Alicea Charamut said hydrilla has been found in East Twin and Bolton Lakes and 2-3 others. Sean Hayden noted the concern about hydrilla being found in lakes without public access. Alicea provided an update on the Army Corps of Engineers work on CT River hydrilla, which will continue with pilot projects next summer, and there was further discussion.
