Minutes of the March meeting were approved

Chairperson update, Adrienne Benjamin

Ms. Benjamin conducted introductions; each council member was allowed to share DDS family member's story.

Ombudsman Update, Ed Mambruno

Mr. Mambruno provided an update on his involvement assisting a young man moving into an assisted living facility. It was also discussed assistance placing individuals with camp placements. Mr. Soby from Oakhill stated that Camp Hemlock has space. Ms. Hlavac inquired about the Title 19 individuals who have temporarily been cut off. Other council members voiced their concerns regarding redetermination issues.

Legislative Update, Rod O'Connor

S.B. 165 An Act Concerning the Department of Developmental Services' Recommendations for Technical Revisions to Its Statutes was amended in the Senate. Senate Amendment A included all of the DDS agency bills. It is anticipated that S.B. 165 as amended will be passed by the House and be signed by the Governor.

A proposed amendment to S.B. 296 An Act Establishing a Pilot Program to Serve People Seeking Residential Services from the Department of Developmental Services has new language around how to make the system more efficient. S.B. 463 An Act Establishing a Task Force to Study the Needs of Persons with Intellectual Disability deals with the continuum of service issues.

S.B. 400 An Act Concerning Graduate Funding and the Provision of Support and Services for Persons with Intellectual Disability has a fiscal note to the bill will need to go to the Appropriations Committee for a vote. The training portion of this bill appears intended to provide retraining of public staff for redeployment in other areas of the department.

H.B. 5460 An Act Concerning Minimum Employee Wages For Providers Of State-Contracted Human Services could impact the DDS budget by up to 50 million dollars over our current budget.

Commissioner's update, Jordan Scheff

RAC's statewide meeting on May 16 – Midstate ARC will be presenting around the alternatives options and technology. The Commissioner has extended the invitation to Council.

Budget conversations are ongoing. A reminder that we have a current enacted budget.

Self-Advocate Coordinators update – No Excuse for Abuse brochure distributed. They are using this as part of their training. A reporter has agreed to meet with the Self Advocates and discuss People First Language and No Excuse for Abuse.

Our Director of Legislative and Executive Affairs – She has noticed DDS that she will be leaving the Dept to go work in the private sector.

Public Home closure – This year we are doing ten conversions, 9 homes have been converted. One home is taking longer than usual.

Job Fair – We had about 200 people attend the job fair and they will be taking other jobs internally.

Southbury Training School's – The census is currently at 201. We currently have 11 active open cottages.

ID Partnership funds were used in accordance with budget language.
