CALL TO ORDER

The meeting was called to order at am by Acting Chairman Galvin at 8:36 am.

 - a. Supervisor: RCR Andrew O'Hazo
 - b. Commissioner Baron made a motion to request the applicant provide 3 additional samples and return at the next meeting, in November, for review. Commissioner Lineaweaver seconded the motion.

COMMENTS OR CONCERNS OF ANY PERSON PRESENT TODAY

- Bruce Hunter approached the Commission to express their concerns regarding the following:
 - The Commissions hearing process, particularly in regards to the sample report/experience review process.
 - Commented that in the standards there is no requirement to explain what is not included in an appraisal report.
 - Commented that the way the Commission reviews the sample reports is inappropriate and hurting the applicants.
 - Concerns that the Commission does not allow public comment during the sample review process.
 - Expressed their opposition to CT increasing the hourly CE requirements.

- Jennifer O'Neill approached the Commission to express their concerns regarding the following:
 - The structure for Public Comment during the meetings
 - Adding additional continuing education hour requirements
 - The sample report review.
 - Commented that the Commission should reconsider the sample review process by including a pre-review prior to it going before the Commission for review. It may allow licensees to provide a better product for final review and could reduce the number of times applicants have to return.

- Debbie Yanosy approached the Commission to clarify if the November meeting will be in-person or virtual. The Commission confirmed that the meeting on November 13 will be held virtually via Teams.
