OLD BUSINESS:

1. Update on the transition from the Certified Employee Training Program (CETP) to the PERC Education Program (PEP)
2. Ratio Relief Discussion
 - a. Electrical Board Chair Vallieres provided an update to the ratio relief policy he and the other board chairs have worked on developing.
 - b. Board Member Rosario moved to adopt the ratio relief policy presented. Board Member Davenport seconded the motion. The motion passed unanimously.

NEW BUSINESS:

1. Applications for Review:
 - a. Franklin Emilcar – HTG.0414075-S2
 - i. Board Member Higgins moved to deny the applicant sit for the S2 exam. Board Member Rosario seconded the motion. The motion passed unanimously.
 - ii. The applicant changed their application to a D2 application
 - Board Member Rosario moved to approve the applicant sit for the D2 exam on or after August 1st, 2026 – providing that the applicant remain a registered apprenticeship. The applicant will need to submit employment documentation to DCP that the applicant remains

gainfully employed. Board Member Davenport seconded the motion. The motion passed unanimously.

b. Philip Mills - S1

- i. Board Member Rosario moved to approve the applicant sit for the S1 exam. Board Member Higgins seconded the motion. The motion passed (4-0-1). Abst: Barrieau
- ii. The board began discussion on equivalency for the Rhode Island Master Mechanical, being a contractor, to the CT S1 license.

2. Appearing for Guidance:

a. Edward Menard – S1 Licensure

- i. The individual holds a G1 license and is looking for guidance on waiving the time requirement to sit for the S1 exam due to holding a contractor license for over 5 years.
- ii. Board Member Rosario moved to waive the time requirement to sit for the S1 exam due to holding an approved contractor license. Board Member Davenport seconded the motion. The motion passed unanimously.

b. Sajjad Chaudhary – S1 Licensure

- i. The individual holds a home improvement contractor registration and is looking for guidance on getting a S1 license. The board recommended the applicant get registered under an S1 contractor and go through the 4-year apprenticeship program. It was also recommended that the applicant get an equivalent education review done.

c. Nolan Bugg – OE2 Licensure

- i. The individual is lacking the education requirements to sit for the OE2 now.
- ii. The board recommended the individual complete the OE2 coursework and continue on the S4 apprenticeship. Once the coursework is complete, they can apply for the OE2 license.
