## **I-Items**

### **Comments or Concerns**

- While reviewing Class 4 applicants via reciprocity the Board began to discuss updating their current review policies
  - **Core Issue:**
    - The board debated whether extensive experience should compensate for the lack of an ABET-accredited engineering degree when evaluating Class 4 reciprocity applicants.
    - Current Connecticut policy aligns with NCEES Model Law, requiring:
      - Education, Experience and Examination

- **Key Points Raised:**

- 1. **Consistency vs. Flexibility**

- Chairman D'Andrea emphasized the need for consistency with Model Law and Connecticut statutes, even if it excludes highly specialized, experienced engineers.
    - Board Members Lewandowski & Thompson questioned fairness, noting cases where applicants with decades of proven expertise were denied due to non-engineering undergraduate degrees.

- 2. **Breadth of Education**

- Board Member DeWolf strongly advocated that an undergraduate engineering degree ensures exposure to multiple disciplines (structural, soils, hydraulics, thermodynamics), which is critical for professional licensure.
    - The concern being that specialists (e.g., physics majors with structural expertise) would lack this breadth despite advanced degrees and experience.

- 3. **Experience Weighting**

- Discussion on whether meeting a minimum years of experience should override educational deficiencies.
    - Current policy allows extra experience for technology degrees (e.g., 10 years), but not for pure science degrees.
    - Some members suggested creating an additional tier for applicants with significant experience.

- 4. **NCEES Evaluations**

- The board noted inconsistencies in NCEES evaluations. And noted that NCEES evaluations are helpful for foreign degrees but not definitive for U.S. science-to-engineering pathways.

- 5. **Ethics & Liability**

- Concern that denying licensure to project leads could reduce accountability for work performed in Connecticut.
    - However, members reiterated that applicants can still practice under another licensed PE—they just cannot sign/seal drawings.

- **Next Steps:**

- **Policy Decision:**

- After extensive debate, the board reaffirmed its current policy:
      - Minimum standard remains an ABET-accredited engineering or technology degree (or equivalent).
      - Experience alone will not substitute for the educational requirement.

## **Adjournment**

Board Member Regina moved to adjourn. Board Member Szewczak seconded the motion. The motion passed unanimously, and the meeting adjourned at 11:45 am.
