Alliance for Water Efficiency – Update (Mary Ann Dickinson):

Rates workshop:

- Date was moved tentatively to March 17, 2021 so that key Regional Water Authority personnel could attend
- If the workshop must be virtual, half day sessions over two days possible, waiting to see how the COVID-19 situation changes, by February make a decision on course of action
- Mary Ann and reviewed the updated excel workbook that showcases legislative research, indicating what was being done in several states relative to water fixture efficiency standards and audits.
- Excel file to be emailed out.
- Excel sheet contains links to the most favored items to research
- Suggestion was made to also look at local ordinances that minimize turf grass irrigation, such as Dallas, TX.

Drought Plan topical sub-work group – Update & Plans:

- Steve R was absent
- The plan is still to have a completed draft report by late fall 2020
- Members are currently working on the recommendations for the report

Domestic Wells white paper / Domestic Wells WQ topical sub-work group (Mike Dietz):

- White paper: Virginia and Mike to revise paper to address comments from the WPCAG review. The conclusions will not change. They will not address the comments on finances
- Restating the recommendation serves as a better conclusion to the paper
- The paper does not focus on water-quality testing; that will be covered in the subsequent topical sub-workgroup
- Possibly inserting some mention of domestic well water quality as a future topic to be addressed

Outreach & Education topical sub-work group (Lou Burch):

- The group has identified two separate audiences
