CALL TO ORDER

The meeting was called to order at 8:30 am by Chairman Rasmussen.

REVIEW OF PREVIOUS MINUTES

- January 08, 2025, Minutes
 - Commissioner Hawkins made a motion to approve the minutes with the discussed edit. Commissioner Lineaweaver seconded. The motion passed unanimously.

OLD BUSINESS

- 1. Robert Nardella, Jr., RCG applicant: Seeks an extension of RSP to pass PSI exam.
 - a. Chairman Rassmussen has recused himself from this review.
 - b. The commission discussed the applicant's previous extensions. The applicant noted that his previous extensions were due to medical reasons. They also noted that they missed the 30-day contingency due to not being able to get the test scheduled in time.
 - c. Commissioner Hawkins made a motion to approve a 90-day extension.

 Commissioner Lineaweaver seconded the motion. Discussion: clarification on when the start date for the extension begins. Commissioner Hawkins rescinded his motion.
 - Commissioner Hawkins made a motion to approve an extension through June 30, 2025. Commissioner Lineaweaver seconded the motion the motion passed unanimously.

NEW BUSINESS

- 1. Michelle Gamache-RCG.1134 seeks 2-hour equivalent CE for her attendance at the 01/21/2025 Economic Forecast Program presented by the Metro NY Chapter of the Appraisal Institute.
 - a. Commissioner Galvin made a motion to accept 2 hours equivalent CE credit for this course. And that DCP can apply 2-hours equivalent credit for any other licensee that submits this course for credit. Commissioner Hawkins seconded the motion. The motion passed unanimously.

- 2. REAC Meeting Schedule
 - a. Chairman Rasmussen inquired about having a virtual meeting set up for the audit team to attend. DCP staff noted that the April meeting has been changed to a virtual meeting to accommodate that.
 - b. Debbie Yanosy approached the Commission about changing the frequency of in-person meetings to allow for more public participation. She proposed that the Commission meets in-person once a quarter instead of every other meeting. The in-person meetings would be June, September and December
 - Commissioner Hawkins made a motion to approve the quarterly inperson meeting changes. Commissioner Rivera seconded the motion. The motion passed unanimously.
- 3. Update: Valuation Bias and Fair Housing course
 - a. Scott Dibiasio provided an update to the Commission regarding the Appraisal Institute's timeline of releasing the updated the course.
 - b. Chairman Rassmussen inquired on if the Commission could potentially allow an extension to complete this new mandatory requirement. The Commission will revisit this option at a later time.

 - a. Vicky Bullock provided an update to the Commission. It is in review with upper management and Vicky is waiting on their approval. Debbie Yanosy noted that once approved they will reach out to the schools to let them know the course is available and schools can begin to apply to provide that course.

- Chairman Rassmussen, in reference to AAL.1373 + AAL.1374, inquired about allowing ½
 hour credits and if that was acceptable again. Scott Dibiasio noted that they have some
 new staff that might not be aware of the full hour requirement and it was likely done in
 error, but would discuss with their Director of Education and state compliance team for
 clarification.
- Commissioner Galvin made a motion to approve all courses with the exception of AAL.1632. AAL.1362 is denied. Additionally, AAL.1373 and AAL.1374 are approved for 7 hours. Commissioner Lineaweaver seconded the motion. The motion passed unanimously.
 - o The motion has been rescinded
 - Commissioner Hawkins made a motion to approve APR.368 through AAL.1346.
 Commissioner Lineaweaver seconded the motion. The motion passed unanimously.

- Commissioner Galvin made a motion to approve AAL.1370 for 14 hours.
 Commissioner Lineaweaver seconded the motion. The motion passed unanimously.
- Commissioner Galvin made a motion to deny AAL.1632. Commissioner Hawkins seconded the motion. The motion passed unanimously.
- The remaining courses are tabled for the next meeting when the Commission receives more information on AQB and IDECC requirements from DCP staff.
- Scott Dibiasio inquired how asynchronous continuing education courses are being approved with AQB-Only with no IDECC approval.
 - Vicky Bullock is looking into the regulatory requirements for these courses.

- Chairman Rassmussen asked DCP if documents for the closed case regarding Joseph C.
 Sansone Company is available to the public, as he is receiving a lot of inquiries from members of the assessment communities.

 - The following hypothetical situation was asked to staff: if the company was still moving forward and went to a different municipality and allegedly gave a value on a property. If that municipality make a complaint, would that become a new case? And that if the municipality wanted to follow through, they would have to take their own action.
 - DCP staff confirmed that that would be a new case.
