MINUTES OF PREVIOUS MEETING:

1. Review of May 09, 2025, meeting minutes.
 - Board Member Sportini made a motion to approve the meeting minutes. Board Member Yusza seconded the motion.

COMMENTS OR CONCERNS OF ANY PERSON PRESENT TODAY:

DCP INVESTIGATIONS DIVISION:

1. Case Report
 - 05.01.2025 to 06.30.2025
 - Open: 7
 - Closed: 32
 - Closed cases resulted in a total of \$1500 AVC forfeitures
 - DCP's Janita Hamel and John Mesner commented on the improvements made internally that have helped create a more efficient investigations process. As well as improving relationships with the building officials which has created more opportunities for enforcement/investigations.

OLD BUSINESS:

1. 2026 ECE Curriculum Update
 - a. Board Member Sportini moved to approve the 2026 ECE Curriculum. Board Member Yusza seconded the motion. The motion passed unanimously.
2. CE Audit Process Review Update
 - a. There are no updates to discuss at this time
3. Continued discussion on limited licenses
 - a. John Mesner noted that the scope of the T1/T2 licenses is obsolete and moving those licenses to a C5/C6
 - b. Board Member Yusza noted his concerns that T1/T2 licensees do not necessarily have the same experience in fire alarm systems that C5/C6 licensees have.
 - c. Chairman Vallieres noted he would like to compare the education and the OJT for both license types before any decision is made to transfer licenses.

NEW BUSINESS:

1. Applications For Review
 - a. Raphael Franca – ELC.0210699-E1
 - b. The board reviewed the applicant's previous work history and education and advised that the applicant pursue an E2 license and work their way up to an E1. They should also provide notarized documentation substantiating the work done within the country for the September 12th meeting for review.
 - c. A decision on this application has been tabled until the September meeting.

- Chairman Vallieres noted that a discussion on Equivalent Licenses, particularly in Rhode Island, will take place at the next meeting. He asked that board members take some time to do some research on this subject for the next meeting.
- The Electrical CE Provider Update Session will take place on July 31st at 9:30am
 - DCP will send out the invitation to all providers.
- John Mesner updated the board about the following:
 - DOL has launched their eLicense system
 - Apprentice Ratios - the new hiring ratio relief process will go into place in October for an ask of relief up to 8. Starting in February if they are asking for over 8 it will go before the Board.
 - There are currently a handful of T2 apprentices that John will work with DOL to try and get these individuals to move into an L6 or C6 apprenticeship.
