OLD BUSINESS:

1. Update on the transition from the Certified Employee Training Program (CETP) to the PERC Education Program (PEP)
 - a. No update for today's meeting
2. Update on CT Apprenticeship Program (D2 and/or S2) with Local 30 Joint Apprenticeship Training Committee (JATC) discussion
 - a. Local 30 withdrew their request for review
3. Ratio Relief Discussion
 - a. The Board continued some discussion regarding ratio relief and developing a Board policy. Further discussion will take place between the Board Chairs in an effort to remain uniform.

NEW BUSINESS:

1. Applications for Review:

- a. Brandon Winzer – HTG.0413152-S2
 - i. Board Member Champlin moved to deny the applicant sit for the S2 exam. Board Member Higgins seconded the motion. The motion passed (6-1-0).
 - ii. The board provided a couple of pathways for licensure. The applicant could pursue an S10 and D1 license. It was explained that pursuing an S10 would require one year of an apprenticeship to then pursue an S2 license after that time.
 - iii. Board Member Rosario moved to approve the applicant sit for the S10 exam and noted that the applicant may apply for an S2 after the year apprenticeship has been completed. Board Member Higgins seconded the motion. The motion passed (6-1-0).
- b. Francisco Santiago – HTG.0414056-S2
 - i. The Board discussed that the applicant would qualify for a D2 license.
 - ii. Board Member Rosario moved to deny the applicant sit for the S2 exam. Board Member Foster seconded the motion. The motion passed unanimously.
 - iii. Board Member Foster moved to approve the applicant sit for the D2 exam. Board Member Higgins seconded the motion. The motion passed unanimously.
- c. Travis Thompson – HTG.0414173-S9
 - i. Board Member Foster moved to approve the applicant sit for the S9 exam. Board Member Rosario seconded the motion. The motion passed unanimously.
- d. Joshua Crocco – HTG.0414253-S1
 - i. Board Member Foster moved to approve the applicant sit for the S1 exam. Board Member Higgins seconded the motion. The motion passed unanimously.

2. Appearing for Guidance

- a. George Kennedy – S1 Licensure
 - i. Board Member Higgins moved to deem Mr. Kennedy's credentials equivalent to apply for an S1 license. They've held a D1 license for 12 years and an S2 for 4 months. Board Member Davenport seconded the motion. The motion passed unanimously.

3. Proposed OE2 regulation change

- a. Board Member Foster moved to approve recommendation of the proposed regulation changes and noted that Local 30 may proceed with the program starting in January. Board Member Higgins seconded the motion. The motion passed unanimously.
